## Declaration

I hereby declare as follows:

- a) I request that The Lifetime SIPP Company Ltd (Lifetime) in conjunction with its appointed administration company, Hartley SAS Ltd (Hartley), arranges the purchase of the above property as an investment of my SIPP.
- b) I have not received any advice from Lifetime and Hartley in respect of the suitability this investment.
- c) I understand the workings and any possible pitfalls of this investment and have sought independent financial advice on the investment prior to proceeding with the investment.
- d) I understand that I am responsible for my own costs and I agree to pay the administration fee and any unforeseen costs incurred by Lifetime or Hartley.
- e) I understand that Hartley will prepare the relevant Deed of Assignment between The SIPP Trustee Company Ltd and the Special Purpose Vehicle Company we have set up to hold title on behalf of the members SIPP arrangement.
- f) In the event that the purchase does not proceed for any reason, I understand that a fee will be charged to cover the costs to date of Lifetime and Hartley.
- g) I agree to fully indemnify Lifetime and Hartley in connection with any liability, loss or damages incurred by Lifetime or Hartley in relation to the acquisition and ownership of the property by my SIPP.
- h) I agree to act as the property manager or appoint a suitable party for the purposes of the SIPP's ownership of the property and I / they will undertake all that would be expected of such a manager and I do not expect Lifetime or Hartley to attend to any function in connection with property management.
- i) I understand the illiquid nature of the investment and the effect this will / may have on the payment of pension and death benefits.
- j) I can confirm that the property will be adequately insured at all times, and I will provide Lifetime with a copy of the annual renewal certificate. Any costs incurred by Lifetime in obtaining insurance will be reimbursed by either the SIPP or myself.
- k) I understand that the property will require a valuation every 3 years and will ensure this is undertaken. Any costs incurred by Lifetime in obtaining a valuation will be reimbursed by either the SIPP or myself.
- l) The information provided in this questionnaire is correct to the best of my belief. I acknowledge should the provision of inaccurate or incomplete information lead to a delay in the purchase, additional costs may be incurred.
- m) I have been advised of all fees payable and understand that some fees are non-refundable even if the purchase does not complete.
